Presenting Problem:

when started taking dream interpretation & revelatory classes in 1999

every time go to classes/revelatory ministry

-got sick before classes

-tired during classes

-losing sleep,

-stomach problems

-difficulty concentrating

Possible generational curse specifically against their gift

-repent for misappropriation of gift for

money, for power, for honor,

- bloodline

- specific Cherokee Nation

-church attending

-streams ministry

-prophetic movement in the US

-any ways in which you have misappropriated your gift

Possible self cursing

-"I wish I never had this gift"-- after seeing bad stuff- repent for this

Ask God to break any specific covenants concerning the revelatory

Mesmerizing spirit--

focuses on the problems—brings problems so close- bigger than God's power and plans for you and God's design.

- To draw our attention to whatever cannot be understood
- Looks bad or painful

Actions:

Repent for where gave honor when it was not due or withheld honor when it was due (think of Cherokee history-- dishonored when should have been honored.)

Asking God to put His spotlight on what the true focus should be and hold His light there as long as He sees fit- till you can see what He wants you to see

This is very prevalent with First Nation peoples--not given honor when it was due

Victim Spirit:

- Prevalent in First Nation peoples
- Often generational
- Experiencing a pattern of being victimized when stepping out in revelatory gift
- To try to deter you from moving out-- helplessness/powerlessness

lie: too painful to move out

Actions: overcoming the Victim Spirit involves receiving honor where honor is due- ties in with the mesmerizing spirit

• Choosing not to accept what is wrong and saying that its right-- calling a spade a spade

• Confronting predator spirit/ bullying "EXCUSE ME!!!"

• Renounce lie that you are a victim, declare the word you are heir with Christ...then fasten your seat belt you will confront it every day in small way-correct wrong stuff

Servant portion--- designed to walk in authority--walking in dominion, prone to the victim spirit- love creating an environment where people thrive

Dealing with the Victim Spirit by doing generational prayer work. Seeking revelation about when it was established in the bloodline,

Also if you can find a person to partner with you in blessing each other's spirit, as your spirit grows and develops, your spirit will increasingly rightly discern what is wrong and call abuse abuse and stand up against the victim spirit. I'm seeing that start to happen with a woman I have been blessing who as a victim spirit.

Cherokees displaced during gold rush---money more important than people perhaps inappropriate Burden bearing-- for the revelatory-- financial compensation more important than people

- **for the church body in the US**
- **for Streams**
- **for specific church or house group**

Actions:

- **repent for bearing a burden that is not yours-- name the burdens- hand them over to Jesus**
- **ask God to instruct your spirit**

Being Native American, there is a question about connections to land that has endured violence and abuse

Actions:

**steps to take, blessing own spirit to walk in truth of who God made you to be
bless servant portion to walk in dominion over the land..**

bless ruler portion for body, soul and spirit to come into alignment with God's

Questions to ponder: Isn't it the Cherokee who appealed to the Supreme Court, won the case, but Pres Jackson refused to honor the court decision resulting in the trail of tears?

Did they curse the land on the way to Oklahoma?
